Julius Berger appoints Goni Musa Sheikh as non-executive director

Between 2000 and 2006, he was the executive director of the Bitumen Project, Akure.

Sheikh held several positions in government including director, Mines Inspectorate Department (MID); director, Mining Cadastre Office (MCO); permanent, Ministry of Mines and Steel Development; permanent secretary, Ministry of Petroleum Resources and permanent secretary, Ecological Fund Office (EFO).
